TERMS AND CONDITIONS

1. To make your *hors des brumes* reservation please confirm the availability of the dates required by phone, then complete and sign the booking form overleaf and return it together with the initial non-refundable deposit of 25%. We will confirm the formal acceptance of the booking on receipt. Bookings run from Saturday 4pm arrival to Saturday 9am departure, and are for the number of people agreed at the time of booking or later.
2. The balance of the rental together with the security deposit is due no less than eight weeks before arrival. We will send you a reminder but if for any reason you don't pay we will have to re-let the property and your booking will be cancelled. Bookings made within eight weeks of arrival require full payment.
3. If you have to cancel after paying the full amount we will only offer a refund if we can re-let and after deducting any expenses or losses incurred in so doing. We reserve the right to cancel any bookings due to unforeseen circumstances with a full refund of all the money paid to us for the rental of the house.
4. The security deposit of £250 will be returned within two weeks of departure subject to any deductions for loss or damage or extra cleaning costs if the property has been left in an unsatisfactory condition. The barn is cleaned, checked and prepared for your arrival we ask that you leave it as clean as you found it.
5. The characteristics of the barn that make it attractive to rent (oak beams, floorboards, staircases, stone steps and paths, ponds, swimming pool etc and the off-the-beaten-track country location) also require care from the occupiers. We don't recommend the house to those with limited mobility or vision or unsupervised toddlers. Please check with us before booking if you have any concerns.
6. We strongly recommend that you arrange travel insurance that covers you for cancellation, loss or injury etc and that you bring your European Health Insurance Card with you. No responsibility can be accepted by us for any loss, damage or accidents which may occur during your stay, or for any consequential loss however arising.
7. A 'house book' is provided on arrival giving local and household information and advice on the use of the swimming pool. We recommend that all adults read this and familiarise themselves with the layout of the barn and gardens on the first day.
8. We live next door but will come around only as necessary to mow, water and tend to the garden and pool at times that suit you, or to provide information, answer questions and help if any problems arise.
